

FACT SHEET

Proof of Identify

This fact sheet provides information about what proof of identity is required when applying for a home.

What proof is required?

When applying for a home proof of identify is required before any offer of housing can be made. Documentation must be original (copies will not be accepted) for each member of your household over the age of 18 that is listed on your application. Proof of identify is based on a 100 point identity check.
